

ORDINANCE NO. 505

AN ORDINANCE BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF LONG BEACH, MISSISSIPPI, AMENDING ORDINANCE NO. 494 ESTABLISHING SCHEDULE OF BUILDING PERMIT FEES AND RELATED FEES AND PENALTY FOR FAILURE TO PAY SAME, BY AMENDING SECTION 1 OF ORDINANCE NO. 494 TO INCREASE THE BUILDING PERMIT FEE TO \$4.00/\$1,000.00 FOR EACH \$1,000.00 -OF BUILDING PERMIT VALUATION IN EXCESS OF \$50,000.00, AND DELETING SECTION 2 OF SAID ORDINANCE PERTAINING TO CREDIT FOR DOCUMENT EXAMINATION/ PLAN REVIEW FEE, AND FOR RELATED PURPOSES.

WHEREAS, the Mayor and Board of Aldermen (the "Governing Body") of the City of Long Beach, Mississippi, (the "Municipality") having made due investigation therefore, do now find, determined, adjudicate and declare as follows:

1. That the Mayor and Board of Aldermen of the City of Long Beach, Mississippi, has the authority to establish a fee schedule for the issuance of various permits required in the planning, building, moving and demolition of buildings; and
2. The Governing Authorities have heretofore adopted the provisions of the International Building Code by enactment of Ordinance No. 478, which code requires the provision of certain services by the City and the issuance of certain building and related permits, and the cost for same and the penalty for failure to pay same should be established; and
3. The Governing Authorities have heretofore adopted Ordinance No. 494 establishing a schedule of Permit Fees, including, Building Permit Fees, Document Examination/Plan Review Fees, Moving Fee and Demolition Fee, and providing in Section 2. of said Ordinance for credit for Document Examination/Plan Review Fee in certain instances; and
4. The Governing Authorities have determined that due to the expense which the City expects to incur in Document Examination/Plan Review, the provisions pertaining to credit for same should be eliminated; and
5. That the present fee schedule for building permits as set forth in said Ordinance No. 494 should be further amended to fix the fee for every building permit reflecting building permit valuation in excess of \$50,000.00, at \$4.00 for every \$1,000 of building permit valuation over and above \$50,000.00.

Now therefore,

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF LONG BEACH, MISSISSIPPI, AS FOLLOWS:

SECTION 1. That Section 1 of Ordinance No. 494, entitled *AN ORDINANCE BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF LONG BEACH,*

MISSISSIPPI, ESTABLISHING SCHEDULE OF BUILDING PERMIT FEES AND RELATED FEES AND PENALTY FOR FAILURE TO PAY SAME, AND FOR RELATED PURPOSES. is hereby amended to read as follows:

SECTION 1. The Schedule of Permit Fees set forth on Exhibit "A" attached hereto and incorporated herein is hereby adopted.

SECTION 2. That Section 2, entitled "Credit for Document Examination/Plan Review Fee" of said Ordinance No. 494, is hereby deleted.

SECTION 3. Ordinance No. 494 is amended as set forth above, only, to otherwise remain in full force and effect.

SECTION 4. Effective Date


It being necessary and in the best interests of the public health, safety and welfare, and to provide the necessary resources to provide continuing plan/document review concerning the construction of buildings and structures within the City of Long Beach, Mississippi, and the immediate preservation of public health, safety and welfare requiring it, this Ordinance shall take effect and be in force from and after its adoption; but notice shall nevertheless be given as provided by law, and this Ordinance shall be enrolled in the Ordinance Book of the City as by law provided.

The above and foregoing Ordinance No. 505 was introduced in writing by Alderman Levens who moved its adoption. Alderman Ponthieux seconded the motion to adopt the Ordinance, and after discussion, no member of the Board of Aldermen having requested the Ordinance to be read by the City Clerk, and the question being put to a roll call vote, the result was as follows:


